We/Us/Loverevenue means *Next Love LTD* who is appearing and acting on this agreement for and on behalf of its affiliates and subsidiaries including Digisec Nordic IPR Limited and Digisec Holding Limited You/Your/Affiliate means the user of the Merchant Website and participant member of the Affiliate Program

Thank you for visiting the Loverevenue affiliate program website located at loverevenue.com (the "Site"). <https://www.loverevenue.com/> ("we", "us") is committed to protecting the privacy your personally identifiable information. We provide this privacy policy ("Privacy Policy") in order to explain our online information practices and the choices you can make about the way your information is used by us. You must agree to this Privacy Policy, in its entirety. If you do not agree to this Privacy Policy in its entirety, you are not authorized to register for an Account on the Affiliate Network.

**Privacy Policies Used in Connection with Your Subscription.** When you register for an Account on the Affiliate Program, we use a password-protected third party portal to store your personal information, and we may share your personal information with such third party ("Third Party Agent" <http://offerit.com/>) as is necessary for the performance of your Account and the Affiliate Program.

## **Personally Identifiable Information.**

We collect personally identifiable information when you register for an Account or otherwise choose to provide personally identifiable information to us. Personally identifiable information is any information that can be used to identify or locate a particular person or entity. This may include, but is not limited to: business entity name and/or your title with the applicable business entity, as well as your personal and/or business entity related e-mail address, mailing address, daytime and/or cellular telephone numbers, fax number, account information (or other information that we require in order to pay any amounts due to you under the Affiliate Program) and/or any other information requested on the applicable Subscriber registration form. For purposes of this Privacy Policy, your account information shall be considered "Sensitive Information."

We collect personal information when you and /or your referred end users as appropriate use our online services. Selected third parties, to whom you and /or your referred end users as appropriate have chosen to disclose personal information, may also provide us with personal information. The types of personal information we may collect could include, for example, username and and other information collected on registration.

## **Non-Personally Identifiable Information.**

We may collect certain non-personally identifiable information about you when you visit certain pages of this Site and/or register for an Account on the Affiliate Program and

share such information with our Third Party Agent. We use the non-personally identifiable information that we collect to improve the design and content of the Site and to enable us to personalize your Internet experience. We also may use this information in the aggregate to analyze Site usage.

Here are the different categories of information that may be collected from your device by the Websites, or by partners, affiliates, and other vendors acting on our behalf:

- The type of browser you used to access the Websites
- The times you accessed the Websites
- The IP address of the device you used to access the Websites
- The pages on the Websites that you viewed
- The pages you visited before navigating to the Website(s).
- Information about the computer or mobile device you use to access the Websites, including hardware model, operating system and version, and mobile network information

### **Cookies and Web Beacons.**

To enhance your experience with the Site, we use "cookies.". For more specific information on the cookies we use, please see Exhibit A, below. Cookies are small packets of data stored on your computer. Cookies are used by your computer's browser to store your preferences. Cookies, by themselves, do not tell us your e-mail address or other personally identifiable information. We use cookies to understand Site usage and to improve the content and offerings on the Site. You may set your browser to warn you that cookies are in use, or to block the use of cookies. Most browsers are set to accept cookies. If your browser is not set to accept cookies, certain uses of the Site may require you to go to your browser user preferences to enable cookies. Each browser is different, so check the "Help" menu of your browser to learn how to change your cookie preferences. If you change computers, operating systems or browsers, or use multiple computers or browsers, you will need to repeat this process for each computer and each browser. We may additionally collect information using Web beacons, which are commonly referred to in the industry as web bugs, pixel tags or Clear GIFs. Web beacons are electronic images that may be used on the Site, in your Account, or in our emails to deliver cookies, count visits and determine if an email has been opened and acted upon.

### **End User Information.**

We do collect personally identifiable information about your end users such as user id, username , user ip address hashed. When end users who visit member affiliate sites click on the advertisement(s) they have chosen to display through their Accounts on the Affiliate Program, we will utilize cookies and/or web beacons to track such end users activities at our site(s). In certain

circumstances, we may use cookie-less tracking methods to track such end users.

### **Use of End User Information**

We use your end user personally identifiable information for the purpose of fraud risk protection and by preventing and detecting security risks, fraudulent behaviour or other criminal activities or activities carried out with the intent to cause damage .

### **Use of Information.**

We use your personally identifiable information: (a) to send you information regarding your Account and the Affiliate Program; (b) to track your compliance with the Terms and Conditions ("Terms and Conditions"); and/or (c) for validation, suppression, content improvement and feedback purposes. You agree that we, or our Third Party Agent, may contact you at any time with updates and/or any other information that we may deem appropriate for you to receive in connection with your Account on the Affiliate Program.

### **How do we Use Information Collected on the Websites?**

We use the information we collect on the Websites for various purposes, including:

- Ensuring our Websites remain relevant to end user needs and are easy to use by providing analytics and other data regarding use of our Websites.
- Sending marketing and promotional communications in compliance with applicable laws.
- Enhancing, improving, or modifying our Websites and services, enhancing security, monitoring and verifying identify or service access, or combatting spam or other malware or security risks.
- Identifying usage trends, determining the effectiveness of our marketing and promotional campaigns and expanding our business offerings.
- Providing confirmations, invoices, technical notices, updates, security alerts, as well as all other support and administrative messages involved in your request or purchase of Loverevenue products and services.
- Alerting you to new products, special offers and promotions that may be offered by Loverevenue and our selected partners.
- Processing your payment for enrolled Loverevenue products and services.

Your information may be disclosed for processing to any other companies within the Group and their employees; any third party service providers who use your personal information to provide services to us – such as: payment settlement service providers, marketing service providers, data verifiers and financial institutions, to the extent necessary for the completion of payments, joint marketing campaigns, facilitate the opening of new accounts, and fraud

prevention for services provided through our website; or any auditors or contractors or other advisers auditing any of the Group's business processes, potential purchasers or investors in any company within the Group. Any processing performed by any recipients will be governed by the necessary data processing agreement in the form and substance required by applicable law, thereby preserving your and/or your referred players rights under applicable data protection laws.

## **Your responsibility towards your referred end users**

If you yourself receive and process personal information from referred end users that you subsequently refer to us then you shall ensure that they have given their express consent to such transfer to us and this personal information is processed and transferred by you to us in accordance with relevant laws but in any event under terms no less stringent than those set out herein. You agree to indemnify us against all claims and associated costs brought against and suffered by us due to your breach of this clause.

### **Information Sharing.**

As a general rule, and other than in connection with the limited exceptions set forth below, we will not sell, share or rent your or your referred end user personally identifiable information to or with others. Notwithstanding the foregoing, we may, from time to time, provide such information to certain third-party administrative vendors for efficiency purposes in providing administrative or program management services in connection with your Account. Any third-party vendor so used has agreed to protect the confidentiality of information provided by us.

Further, we reserve the right to share your personally identifiable information: (a) where required by law, or requested by a court of competent jurisdiction; (b) in the event of any reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or any portion of our business, assets or stock; (c) where you are in violation of this Privacy Policy, the Terms and Conditions and/or Services Agreement; (d) in the case of a dispute; or (e) where we determine, in our sole discretion, that such disclosure is necessary to protect our rights and/or a third party, or necessary to protect us from liability of any kind. The aforementioned includes exchanging information with other companies and organizations for fraud protection.

We ensure that your and/or your referred end users information will not be disclosed to government institutions or authorities unless:

- we have your and/or your referred end users written consent to share such personally identifiable information with third parties;
  - we require your and/or your referred end users personally identifiable information to provide the services that you have requested (if any)
  - we respond to subpoenas, court orders or legal process;
  - we find that your and/or your referred end users actions on our web sites violate our terms of service, or any of our and/or you referred players usage guidelines for specific services.
- In addition, we reserve the right to disclose and transfer your and/or your referred end users personal data to our respective payment settlement service providers and financial institutions

### **International Transfer of Data.**

As part of your membership in the Affiliate Program, we may transfer information that we collect about you and your referred end users, including personal information, to affiliated entities, or to other third parties across borders and from your country or jurisdiction to other countries or jurisdictions around the world. If you or your referred end users are located in the European Union or other regions with laws governing data collection and use that may differ from U.S. law, please note that you are transferring information and permitting the transfer of information, including personal information, to a country and jurisdiction that does not have the same data protection laws as your jurisdiction. ### **Data Retention.**

Subject to any mandatory obligations to delete data, your information may be retained by us and in our Third Party Agent portal, server logs, databases and records until fulfillment of legal obligations and we may also retain your data for fraud prevention purposes.

### **Third Party Links.**

The Site may contain links to third-party websites ("Third Party Websites"). Please be aware that we are not responsible for the privacy practices of Third Party Websites. We encourage you to be aware when you leave the Site and to read the privacy policies of each and every website that collects personally identifiable information. This Privacy Policy applies solely to information collected by the Site.

### **Links to Third Party Sites**

Our Website includes links to other websites whose privacy practices may differ from those of Lovevenue. If you submit personal information to any of those sites, your information is governed by their privacy policies. We encourage you to carefully read the privacy policy of any website you visit.

- with third party vendors, consultants and other service providers who work for us and need access to your information to do their work such as providing customer support, processing payments, and storing data (e.g. Amazon Web Services). Any third-party vendor so used has agreed to protect the confidentiality of information provided by LOVEREVENUE;

- if required to do so by law, such as to comply with a subpoena, or court order or in the good-faith belief that such action is reasonably necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;

### **Your Employees.**

You agree that any of your employees that access your Account, or visit the Site under the scope of their employment with you agree to the terms of this Privacy Policy. The data of your employees will only be processed in connection with the performance of the contract in accordance with the terms of this Privacy Policy.

### **Minors.**

We encourage parents and guardians to spend time online with their children and to participate and monitor the interactive activities of their children. We will never knowingly collect any personal information about individuals under eighteen (18) years of age. If we obtain actual knowledge that it we have collected personal information about an individual under eighteen (18) years of age, that information will be immediately deleted from its database.

### **Security.**

We endeavor to safeguard and protect our Account holders' information. When Account holders submit personally identifiable information to the Affiliate Program, their personally identifiable information is protected both online and offline. When our registration process asks registrants to submit Sensitive Information (such as bank account information and/or credit card information), and when we transmit such Sensitive Information, that Sensitive Information is encrypted and protected with SSL encryption software. While we use SSL encryption to protect Sensitive Information online, we protect all other user information online and offline. The Third Party Agent servers that we utilize to store personally identifiable information in are kept in a secure physical environment. The Third Party Agent has security measures in place to protect the loss, misuse and alteration of personally identifiable information stored on its servers.

Please be advised that, although we take every reasonable precaution available to protect your data, no data transmission over the Internet can be guaranteed to be 100% secure.
